2. TERM OF STORAGE

The initial term of storage shall commence on (month & year) _____ and will terminate on (month & year) _____. Subsequent terms will follow the same schedule unless terminated by either party with 30 days written notice before the end of the current term.

3. FEES AND PAYMENT

In consideration of the services provided, the Customer agrees to pay Specialized Auto Storage the sum of the agreed upon amount from which storage package has been chosen.

4. INSURANCE REQUIREMENTS

The Customer agrees to maintain comprehensive insurance coverage on the stored vehicle(s) throughout the storage period. The insurance policy must cover theft, fire, vandalism, and any other potential risks. The Customer shall provide proof of insurance to Specialized Auto Storage upon request.

5. VEHICLE CONDITION AND RELEASE

Upon storage, the Customer shall deliver the vehicle(s) to Specialized Auto Storage in good working order. Specialized Auto Storage is not responsible for any damage to the

vehicle(s) that existed prior to storage. The Customer acknowledges that Specialized Auto Storage will not be liable for any damages incurred during storage unless caused by Specialized Auto Storage's negligence.

The Customer may request the release of the vehicle(s) before the end of the storage term by providing Specialized Auto Storage with a written notice at least 10 days in advance. In such cases, the Customer shall pay any outstanding fees and charges along with a \$299.00 fee for removing vehicle early during winter months (Nov 1st - April 1st)

6. TERMINATION

Either party may terminate this Agreement with written notice if the other party breaches any material term or condition of this Agreement.

7. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts.
